This certificate attests to the product performance of fire reaction and that all provisions concerning the assessment and verification of constancy of performance described in the harmonized reference technical specification:

Are applied and that the product fulfills all the prescribed requirements.

Product fire reaction performance: B_{fl} – s1, valid when glued (acrylic glue) on any A2-s1,d0 or A1 class substrate with a thickness \geq 6 mm and density \geq 1350 kg/m³.

This certificate can only be used in conjunction with the declaration of performance of the product written by the manufacturer or his authorised representative established in the European economic area and with the technical specification in reference.

This certificate is first issued on 14^{th} of June 2016 and, except for withdrawal or suspension, remains valid as long as the conditions laid down in the corresponding technical specification in reference or the manufacturing conditions in the factory or the factory production control itself are not modified significantly.
